- **INTRODUCTION**

The ICD-cum-CFS at Rewari is set up on an area of 24.44 acres by Haryana State Warehousing Corporation, to provide cost effective services to the Exporters/Importers of adjoining areas of Haryana, Rajasthan, part of Punjab and Western Uttar Pradesh. The ICD/CFS facilities are being provided by Haryana Warehousing Corporation since August, 1999 and CONCOR has been looking after the rail transfer of Containers to the designated ports like Mundra, JNPT,etc. At present both the facilities viz. ICD/CFS are being looked after by CONCOR under a strategic alliance agreement.

- **IDEALLY LOCATED**

Rewari is ideally located and has been taking care of the Exporters/Importers of various items like GuarGum, Stone, Slate/Tiles, Hosiery, Rubber goods, medicines, Refrigerated Gas, Tools, Steel Coils, Machinery etc. coming from the industrial area of Gurgaon, Rewari, Dharuhera, Shahjahanpur, Neemrana, Bawal, Alwar, Bhiwadi, Bhiwani, Kund, Ateli, etc.

 - ❖ Provide bonded warehouse facilities;
 - ❖ Survey and inspection of containers;
 - ❖ Repair yard for equipment and other related equipment;
 - ❖ Any other container handling and transportation service.
 - ❖ Marketing.

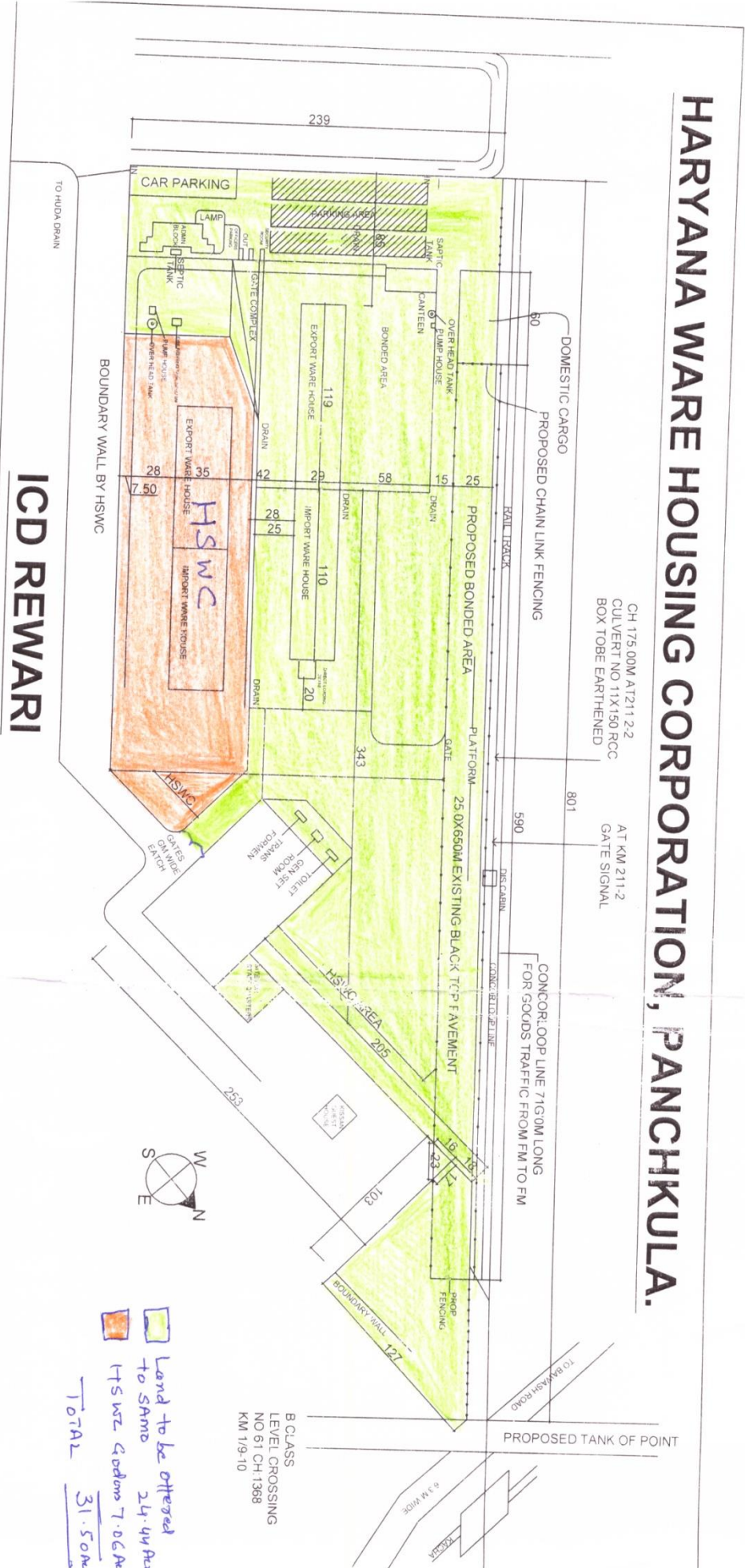
