4. PROCUREMENT OF WHEAT, PADDY & BAJRA, MOONG, MUSTARD, SUNFLOWER & GRAM

The Corporation is one of the State agencies for procurement of Wheat, paddy and Bajra for Central Pool at the Minimum Support Price. It started with procuring only two items i.e. wheat and paddy w.e.f. 1983-84 and 1997-98 respectively.

5. EXTENSION SERVICE SCHEMES

The Corporation is running two extension service schemes namely Disinfestation Extension Service Scheme (DESS) and Farmers Extension Service Scheme (FESS).

i) FARMERS EXTENSION SERVICE SCHEME

The Corporation imparts free training to the farmers about scientific storage of agricultural produce and Disinfestation measures. The warehouse staff visits surrounding villages to acquaint and demonstrate to the farmers, the benefits of scientific storage. During the year 2019-20 in 345 villages, 3621 farmers were educated.

During the current year 2020-21 the technical staff of the Corporation covered 198 villages under this scheme and educated 2633 farmers upto 31.01.2021 about various methods of scientific storage and preservation of their foodgrains and also demonstrated the disinfestation measures besides acquaint them about the benefits of scientific storage and the facilities being provided by the Corporation upto 31.01.2021

ii) DIS-INFESTATION EXTENSION SERVICE SCHEME

Under this scheme, stocks of farmers, cooperatives, traders and others are disinfested in their own homes/godowns. During the year 2019-20, 1704 people availed benefit from this scheme and Corporation earned Rs. 6.47 lakh under this scheme against the target of Rs 15.00 Lakh.

During the current financial year 2020-21, the Corporation against the target of Rs. 15.25 lakh has earned an amount of Rs. 7,11,809 under DESS and 1452 numbers of beneficiaries availed themselves of this facility upto 31.01.2021.
